Level 3-5 State Meet Format – will be run in the modified Capitol Cup format for L-4&5 and either modified traditional or modified Capitol Cup for L-3. This will require a minimum of 3, but possibly 4 sets of equipment and a facility large enough to accommodate equipment, seating and parking. Rationale – the increased cost is preferable to conducting Friday competition or splitting levels to different weekends. L3-5 entry fees will be raised from \$60 to \$70 to offset the higher cost.

Wisconsin State Meet Banners – WI-USAG will buy the 3 large year/level nonspecific banners from Doug Jonuska that were used at the 2014 L-3-5 State Meet for \$500 to be used by State Meet directors.

Xcel State Meet Participation Awards – will be required.

Xcel State Meet will include Bronze Division – effective this year (2015) to accommodate the Regional qualification opportunity.

Judges Assigning Fee - \$3/Judge – will be paid to WI-NAWGJ in a lump sum payment from WI-USAG out of the head tax fund (effective Jan. 1, 2015). Meet directors will no longer be required to make these payments.

Head Tax remains the same - \$2/athlete for seasonal sanctioned meets to be paid by meet directors to WI-USAG. Compulsory and non-USAG

sessions are not taxed at Optional season invites. See WI Rules & Policies.

L-2 Achievement Awards (Ribbons) – will now follow USAG R&P guidelines to be identical to L-3. The adjustment formerly used no longer seems relevant in score ranges and this should help eliminate confusion.

- Blue – 9.00
- Red – 8.00 8.50**
- White – 7.50
- Yellow – 7.00

(Below 7.00 at discretion of meet director)

L-2 Score Posting (Clarification) – Consistent with the state’s L-2 philosophy of low-key participation rather than intense competition, L-2 meet results can be posted as an All Around listing but not by Event placement. *ProScore* provides this format. Team competition is not conducted for L-2.

NOTE: Submit Compulsory Meet Date Requests to SACC by Mar. 1 Deadline. Include 3 choices of dates, facility/location and any other pertinent info.
