II. Motion to approve minutes of May 12, 2017 SAC meeting.

- III. State Financial Update Current balance, approximately \$32,000. After projected income and expenses for this year, the balance is expected to remain about the same \$32,000. Approximately \$6,000 net cost for last summer's Educational Clinics after income generated from the clinics was added back in.
- IV. The SACC, Randy Anderson reappointed Justin Slife for another year as Education Committee Chair. We had good feedback about the clinics held and work done by the committee in its first year.
 - Our target is to provide \$10,000/year to fund the Education Committee's clinics with hopes of recouping some back from clinic-generated income.
 - As a future clinic suggestion, Justin Slife recommended a round table discussion type clinic hosting International Brevet judges (or other high level judges) for coaches to "pick their brains" regarding routine composition and other pertinent issues.
- V. Following the recent improvements to the State Website (www.USAGymWl.com) and wider spread use of the published USAG-WI R&P and State Meet Directors Handbook, things seem to have run smoother with fewer problems arising.
- VI. Spring Elections The SACC position is up for re-election. Randy Anderson has consented to run for the position again. The election process will be conducted through USA gymnastics if an election is warranted.

VII. State Meets

• Julia Straszewski, (Wildcard) did a commendable job running a successful 2017 Level 3-5 State Meet at Vincent High School in Milwaukee.

- Since all State Meets are under the total jurisdiction of the SAC, it was noted that a SAC
 member MUST be present throughout the duration of the competition. This could be a
 judge or coach already committed to being on premises for other responsibilities, e.g., Meet
 Referee. In this case no additional fee would be charged to the meet for this particular
 service.
- Pre-State Meet administrative duties require an enormous amount of SACC and/or SAC member consultation and coordination with the meet director.

Motion to charge all State Meet directors a **\$1,000** administrative fee* to be paid to a SAC member assigned to consult with the State Meet Director for coordination and approval of adherence to USA Gymnastics and USAG-WI Rules & Policies.

*Fee subject to be waived or reduced in cases of nominal SAC member involvement.

Level 2 numbers are declining in Wisconsin. We are back to the point that we can combine
 Level 2 with the Level 3-5 State Meet.

Motion to drop Level 2 from the *State Meet First Priority Bid Rotation* and combine Level 2 with the Level 3-5 State Meet starting in 2018.

This will be accomplished by including fall season **Xcel competition at Compulsory meets**. Compulsory meet directors may designate if and what Xcel Divisions they will accommodate at their Compulsory meets.
- XII. Even though *USA Gym Meet Reservation System* now provides an option for third party payment, USAG-WI does NOT permit any added fees to be charged for Compulsory Qualifiers and State Meets. Reminder, all meet entry forms MUST be typed. Handwritten entries will be returned.

XIII. The UASG-WI Regional Apparel policy is to provide a leotard for all Level 9/10 Regional qualifiers and Level 8 Super 8 Team members. All Level 8-10 Regional qualifiers and Regional coaches receive a USAG-WI T-shirt.

Motion to continue the current Regional apparel policy and not to extend it to include L6/7 or Xcel.
