- IV. State Financial Update Current balance is \$32,870.77 but anticipate a balance of approximately \$46,000 after pending expenses and collections. With the uncertain status of USA Gymnastics, the holder of USAGym-WI funds, it might be wise to spend down our balance.

- X. Xcel Issues
 - The new policy of allowing Xcel divisions into fall Compulsory meets was met with low response this past season, but we will continue the same policy next fall.
- XI. All SAC members are required to annually complete and submit USA Gymnastics Conflict of Interest questionnaires and Confidentiality forms. Please submit immediately if still pending.
- XII. New Items
 - It was proposed to have a chart created to simplify Level 2 awards at State Meet which are based on percentages of participants.
 - Reminder: **Refund Policy** The Wisconsin State policy for refunding Compulsory season meet entry fees is 30 days prior to the first day of a weekend competition. Full refunds will be given for any reason up to that date. No refunds are given for any reason within 30 days of the meet. Clubs failing to pay required entry fees will suffer the consequences of ill will created between the clubs even if the meet host has no recourse to enforce payment.
 - **SafeSport** regulations require ALL club personnel to take the SafeSport course. Observation this policy seems extreme and impractical when considering actual application.
