

# DEV State Meet Reminders and Reporting:

Updated 2/27/24

- All clubs need to be reminded that:
  - Level 6-10 athletes who will compete at Regionals, provided they qualify, MUST be registered (via the USAG meet reservation system) **prior to their state's championship meet**
  - Level 6, 7, 8 athletes do NOT have to declare IES prior to the start of the state meet. Level 9 and 10 athletes who do not achieve an AA qualifying score to Regionals, can still advance to Regionals on the events they achieve the IES score. (Region 4 Committee, February 22, 2024)
  - ~~○ Level 6, 7, 8 IES athletes must be declared prior to the start of the State competition to be eligible to qualify for Regionals~~
  - Level 9 and 10 athletes do NOT have to declare IES prior to the start of the state meet. Level 9 and 10 athletes who do not achieve an AA qualifying score to Regionals, can still advance to Regionals on the events they achieve the IES score. (NDPC minutes, May 2023)
  - Athletes who cannot compete at State due to illness or injury or who cannot finish competing at State (prior to the 4<sup>th</sup> event), who want to compete at Regionals, must complete the USAG petition form (available on the USAG website) and email it to Region 4 Technical Committee Chair, Windee Weiss, at: [windee4rtc@gmail.com](mailto:windee4rtc@gmail.com) by the Monday following the conclusion of the State meet. Late petitions will not be accepted.
  - Athletes who fail to qualify for Regionals must be scratched from the USAG reservation system at the conclusion to the State meet. Athletes who are not scratched will be charged the Regional entry fee.
  - Coaches who plan on coaching at Regionals must be entered in the USAG reservation system. On-site coach registration (at Regionals) will be \$100. NO EXCEPTIONS!
  - All qualified and petitioned athlete entry fees must be paid (through Meet Maker) at the conclusion of the State Championships.
    - Level 7,8, 9, 10: \$150.00/athlete
    - Level 6: \$135.00/athlete
    - If petitions are not approved the entry fee will be refunded
    - Please have your Meet Maker account set up prior to the State Meet
- Qualifying Scores:
  - All-Around:
    - All Levels: 34.0
    - Can inquire on lowest scoring event if score is 33.9-33.975
  - IES
    - Level 9, 10: 8.5
    - Level 6, 7, 8: 9.0

- Directions for State Chairs or their appointees:
  - All results must be posted on the MYUSAGYM app by the conclusion of each session
  - Import **all Level 6, 7, 8, 9, 10** Results from ProScore (or similar program) into the attached Excel reporting spreadsheet – **do NOT submit pdf or word documents**
  - Sort by Level, each level has its own tab on the spreadsheet
  - Only include the information listed on the spreadsheet
  - Sort by team, then score (highest to lowest)
  - Note any petitioned or IES athletes
  - Name the file: STATE NAME\_Reporting
  - Double check these results with the athletes who are registered for Regionals in the USAG reservation system
    - Scratch any non-qualifiers

    - E-mail this ASAP – no later than noon Monday following the conclusion of the State Meet
