II. **Changes and Updates to 2026-27 WI Rules & Policies**

- State meet directors will be responsible for ordering their own state meet medals, the SACC will no longer order or hold inventory. The state meet directors are encouraged to reach out to the previous state meet director to purchase surplus medals before ordering new.
- State meet financial reports must be sent to the State Chairperson within 90 days after the state meet.
- The Fall Compulsory & Xcel Bronze qualifier schedule will be emailed to membership by May 31.
- **Level 2-5 & Xcel Bronze State Meet bid deadline**
